

DIRECTIONS TO THE NOTTAWASEPPI HURON BAND OF THE POTAWATOMI TRIBAL COURT

FROM DETROIT, ANN ARBOR, JACKSON AND POINTS EAST:

Take I-94 west to Exit 98 which is Michigan 66. Take M66 south toward Sturgis until you see the Potawatomi Reservation sign at S Drive. Turn right onto S Drive, the only way you can turn, and stay on S Drive heading west until you come to 1 ½ Mile Road and another Reservation sign. Turn left onto 1 ½ Mile Road and follow it for approximately ½ mile until you see the cluster of buildings. The Tribal Court is located in the basement of the Administration Building which is the first large building on the right. The address is 2221 1 ½ Mile Road. Come into the reception desk and they will let the Court know that you have arrived.

FROM LANSING AND POINTS NORTH:

Take I-69 south to I-94 west to Exit 98 which is Michigan 66. Take M66 south toward Sturgis until you see the Potawatomi Reservation sign at S Drive. Turn right onto S Drive, the only way you can turn, and stay on S drive heading west until you come to 1 ½ Mile Road and another Reservation sign. Turn left onto 1 ½ Mile Road and follow it for approximately ½ mile until you see a cluster of buildings. The Tribal Court is located in the basement of the Administration Building which is the first large building on the right. The address is 2221 1 ½ Mile Road. Come into the reception desk and they will let the Court know you have arrived.

FROM GRAND RAPIDS:

Take I-131 south to I-94, exit 74. Go east on I-94 toward Battle Creek. At Exit 98 which is Michigan 66 go south toward Sturgis. Stay on M66 until you see the Potawatomi Reservation sign at S Drive. Turn right onto S Drive, the only way you can turn, and stay on S Drive heading west until you come to 1 ½ Mile Road and another Reservation sign. Turn left onto 1 ½ Mile Road and follow it for approximately ½ mile until you see a cluster of buildings. The Tribal Court is located in the basement of the Administration Building which is the first large building on the right. The address is 2221 1 ½ Mile Road. Come into the reception desk and they will let the Court know that you have arrived.

FROM ST. JOE, BENTON HARBOR, KALAMAZOO AND POINTS WEST:

Take I-94 east to Battle Creek Exit 98 which is Michigan 66. Go south on M66 toward Sturgis. Stay on M66 until you see the Potawatomi Reservation Sign at S Drive. Turn right onto S Drive, the only way you can turn, and stay on S Drive heading west until you come to 1 ½ Mile Road and another Reservation sign. Turn left onto 1 ½ Mile Road and follow it for approximately ½ mile until you see a cluster of buildings. The Tribal Court is located in the basement of the Administration Building which is the first large building on the right. The address is 2221 1 ½ Mile Road. Come into the reception desk and they will let the Court know that you have arrived.

FROM COLDWATER, MICHIGAN, FT. WAYNE, INDIANA AND POINTS SOUTH:

Take I-69 north to Exit 25 which is Michigan 60. Turn left and go west on M60 until it intersects M66. Turn right onto M66 and travel through Athens going north until you see the Potawatomi Reservation sign at S Drive. Turn left onto S Drive, the only way you can turn, and stay on S Drive heading west until you come to 1 ½ Mile Road and another Reservation sign. Turn left onto 1 ½ Mile Road and follow it for approximately ½ mile until you see a cluster of buildings. The Tribal Court is located in the basement of the Administration Building which is the first large building on the right. The address is 2221 1 ½ Mile Road. Come into the reception desk and they will let the Court know that you have arrived.
